

## TOURNAMENT INFO

A round robin or double elimination format will be played depending on draw size within each division. Scoring format will be explained prior to beginning of tournament and may be changed by tournament officials when required by time constraints.

## FIRST ROUND MATCH TIMES

**Players are responsible for obtaining their first round match times.** Draws and match times will be posted on the website by the Wednesday prior to start of tournament, or call one of the tournament directors.

## SCHEDULING

First round matches may be scheduled as early as 8am on Friday. If you have an issue with a Friday match, please indicate on your entry form, and enter only one event. All finals will be scheduled for completion by 5pm on Sunday. Schedules may be delayed in the event of inclement weather

Players are requested to **arrive at the tennis courts for warm up 30 MINUTES PRIOR** to their scheduled match time. A 15 minute default rule will be enforced.
